- 3. **Training Delivery:** Conduct 7-day training as per AVN TRUST /SDF-approved schedule and content.
- 4. Monitoring & Reporting:
  - o Maintain batch-wise attendance and documentation.
  - o Submit reports, photos, and case studies after completion of each training batch.
- 5. **Financial Compliance:** Ensure proper utilization of funds and submission of bills, receipts, and utilization certificates.
